We agree to:

- 1. All volunteers must sign up prior to Wednesday, 10/11.
- 2. For volunteers over the age of 14, the Short Term Agreement is required to sign every three days. Group Leaders are responsible to ensure all eligible volunteers sign the Short Term Agreement before participation. The agreement can be signed upon arrival on Thursday, Friday and Saturday nights. Before any work begins, this form must be completed, every three days.
- 3. Improper, unprofessional conduct will lead to immediate expulsion from the event.
- 4. Do not stop or block Visitors. Never touch, bump, or come in contact with any park visitor. Stay an arm's length away from visitors at all times. Cursing or bad language is never tolerated.
- 5. If accidental contact does occur, please apologize, and step back.
- 6. Costumes are encouraged but be aware of your demeanor out of the Scare Zones.
- 7. Group Leaders are responsible for emergency contact information for each group participant.
- 8. In the event of an emergency, notify FWC Law Enforcement or Park Ranger.
- 9. Scare Zones must be set up before event. All electronics must be tested and live on Thursday, 10/19 during rehearsal.

I agree to follow all the safety guidelines, volunteer protocols and rules of the Hillsborough River State Park during Haunted Woods before, during and after the event.

I understand that the volunteers are not considered to be employees of the State of Florida; however, volunteers are covered by state liability protection (Section 768.28, F.S.) and by

workers' compensation (Chapter 440, F.S.). No other benefits of collective bargaining agreements apply.

I also understand my service can be terminated by the Florida Park Service with or without cause, and I do no have the right to grieve or appeal this decision or I can terminate my volunteer status at any time with or without cause. I understand that volunteers on duty for the Department may be photographed or videoed and the materials may be used to promote the Department. No further releases are required.
